| 2. | For the line items stating "Loaded by Supplier onto BOARD truck(s) at pit location" — can you confirm: • That PGCPS will be sending their own trucks? • And that we, as the supplier, are expected to load those trucks using our own loader at the pit? | Vendor's pit location shall be situated no more than twenty miles from Prince George's County Correct. Loaded by supplier onto board trucks |
